## **Privacy Statement**

### **An Important Notice Concerning Privacy from American Express Travel Related Services Company, Inc., American Express Centurion Bank and Amex Assurance Company.**

This Privacy Notice explains how we collect and safeguard personal information and the choices you have about the use of that information, when you enroll for Global Travel Shield insurance products.

This Notice is addressed to United States purchasers of Global Travel Shield insurance products (“Customers”). We call these insurance products “Global Travel Shield.”

#### **What Information Do We Collect?**

When you purchase Global Travel Shield, we obtain information about you from a variety of sources. You give us information about yourself when purchasing Global Travel Shield. This includes your name, address, e-mail address, approximate age, names and approximate ages of Additional Covered Persons, payment information (including credit card number and expiration date), information about your beneficiaries and their relationship to you, and information about your travel plans, such as cost, departure and return dates, destination and carriers. We also obtain information about the company that referred you to Global Travel Shield if your purchase of Global Travel Shield results from a referral from one of the companies we work with to tell consumers about Global Travel Shield. We also obtain information from our affiliates about your transactions with them. We call all of this information “Customer Information”. Our affiliates are other companies in the American Express family that are under common control or ownership with us. These include financial advisors, insurers, publishers, and travelers cheques issuers.

#### **What Do We Do with This Information?**

We use Customer Information to deliver Global Travel Shield insurance products and services to you. To do this it's often necessary to share it with our affiliates and companies that perform services for us. These include companies that underwrite Global Travel Shield products and provide customer servicing and claims processing and marketing services on our behalf. And we may disclose it to other third parties as permitted by law. For example, we disclose Customer Information in response to subpoenas and other legal processes.

#### **Your Choices**

You have “opt out” choices about certain other uses and disclosures of Customer Information.

#### **Offers for Products and Services of Other Companies**

We work with other companies to tell consumers about the availability of Global Travel Shield. If your purchase of Global Travel Shield results from a referral from one of these companies, we may disclose Customer Information to that company so that you may receive offers for their products and services.

#### **Offers for American Express Products and Services**
